## Regulations and Election of the Delegate's Meeting for the four-year period 2023/2026

Dear Sir / Madame,

the mandate of the delegates of the active insured and pensioners at the Delegates' Meeting of Fondazione di Previdenza EFG SA ("Fondazione") will expire at the end of 2022, new delegates need therefore to be elected for the four-year period 2023/2026.

The Delegate's Meeting consists of representatives of all insured persons, whether active or retired, appointed at the ratio of 1 representative for every 50 active insured or pensioners. The Foundation Board has defined the method of appointment in an Electoral Regulation and has set out the steps of the process, which you will find attached.

We would like to briefly explain the most important points of the regulation hereafter.

The Delegate's Meeting operates as an advisory and general control body of Fondazione and, it assumes in this context the following general tasks: examination of the annual balance sheet and the annual management report, examination of the auditor's reports, appointment of representatives of the active insured to the Board and dealing with general pending business. The Delegate's Meeting plays an important role by obtaining information from the Board and informing the active insured and pensioners.

## Your candidature is therefore very important!

If you have any questions or need further clarification, you can address your queries not only to the Administration, but also to the Electoral office consisting of Antonella Spaggiari, Valeria Rimoldi and Yves Bersier.

We warmly invite those who would like to candidate to notify us by 06.10.2022 to the e-mail address elezioni.prev@efgbank.com or in paper form to Fondazione di Previdenza EFG SA, Electoral office, Viale Stefano Franscini 8, 6900 Lugano (postmark applies).

The period set for the election of delegates runs from 18.10.2022 to 20.10.2022; you will be duly informed prior to voting in relation to the voting modalities.



The current representatives of the active insured in the Foundation Board will remain in office until the approval of the 2022 accounts (spring 2023). At the Delegates' Meeting 2023, when the annual accounts as at 31.12.2022 will be presented, new representatives of the active insured persons on the Foundation Board will be elected.
