# EFG International conclut son programme de rachat d'actions

Zurich, le 12 mars 2019

EFG International AG annonce aujourd'hui l'achèvement du programme de rachat de ses propres actions nominatives tel que communiqué initialement le 27 avril 2018.

Le programme de rachat d'actions d'EFG a débuté le 27 juillet 2018 et s'est achevé le 12 mars 2019. EFG a racheté un total de 6 000 000 actions nominatives, équivalant de 2.07% du capital-actions en juillet 2018, à la SIX Swiss Exchange pour un montant de CHF 40 572 422 par le biais d'EFG Bank AG, une filiale détenue à 100% par EFG. Les actions rachetées sont utilisées pour financer les actions subalternes cédées dans le cadre du plan de participation des collaborateurs afin d'éviter une dilution provoquée par l'émission d'actions sur le capital conditionnel.
