## 1 - Annual report 2022

The Foundation Board (Board) of Fondazione di Previdenza EFG SA approved the Annual report 2022 during its meeting last April 20, 2023, the same was presented to the Delegate's Meeting on May 15, 2023.

The financial year 2022 closed with a slight underfunding (98.5%), basically due to the negative performance achieved (-10.06%) in this very difficult year for the financial markets.
