

**Announcement of the intended amalgamation of EFG Private Bank (Channel Islands) Limited (a Guernsey company with registered number 25287) ("EFGIG") and EFG Bank AG (a Swiss share company with registered number CHE-105.956.745) ("EFGAG")**

Following the amalgamation, EFGIG will cease to exist. However, all property and rights to which EFGIG was entitled to and any liabilities that EFGIG was subject before the amalgamation shall become the property, rights and liabilities of EFGAG from the date of amalgamation. Any member or creditor of an amalgamating company, or any person to whom an amalgamating company is under any obligation or liability is entitled to be supplied free of charge with a copy of the resolutions approving the amalgamation upon request to an amalgamating company.
